Gratuities (in USD)

Gratuities are recommended to be prepaid for the group at the rate of \$58 per person for the entire cruise. This gratuity includes for the stateroom steward, head waiter, waiter and assistant waiter.

Suite Gratuities (in USD)

Gratuities are recommended to be prepaid for the group at the rate of \$70 per person for the entire cruise. This gratuity includes for the stateroom steward, head waiter, waiter and assistant waiter.

Third and Fourth Guests

Triple and quadruple accommodations are subject to availability at time of booking and are not guaranteed.

Fit to Travel Policy

If a pregnant guest has entered or will be entering their 24th week before or during the cruise, they are **NOT ABLE** to travel. Guests who are pregnant and under 23 weeks of pregnancy for the length of the cruise must have a fit to travel note from their physician. Guests with a disability are not required to travel with another person as a condition for traveling on our ships. However, our personnel are not required to perform personal tasks (e.g. assisting with eating, dressing, toileting or lifting) and therefore, guest requiring assistance with these functions should consider these needs when making a booking. If there is a question regarding the guest's fitness to travel without personal assistance, this must be discussed with our Access Department.

Infant Policy

Infants sailing on a cruise must be at least 6 months old as of the first day of the cruise and/or CruiseTour. For transatlantic, transpacific, Hawaii, select South American and other selected cruises and/or CruiseTours, the infant must be at least 12 months old as of the first day of the cruise/CruiseTour. For the purposes of this policy, any cruise that has 3 or more days consecutive at sea will require infants to be 12 months old on the first day of the cruise/CruiseTour.

Single Occupancy

Single occupancy fares are 200% prior to taxes and fees. Royal Caribbean International reserves the right to limit the number of single occupancy staterooms.

Group Amenities Plus Program

As long as 8 or more staterooms are **booked within 30 days** from the group's creation, the group will qualify for **4 GAP points**, \$50.00 of onboard credit per stateroom. The GAP points will be added 24 – 48 hours after the initial 8 staterooms are deposited. If the hold is extended by an additional 30 days and the group does not have the initial 8 staterooms, the group will not qualify for this amenity. We may also offer discounted pricing which may not qualify for this amenity. Should there be a price adjustment prior to the final payment date, we will advise if the GAP is still applicable to the new rate.

Payment Schedule for Interior, Ocean view, Standard Balcony, Triples, Quads, and Suites
